





One of the most overlooked expenses that we incur is transportation. Yearly mileage for 2021 - 2022 topped out at 191,498 miles! That is equal to going around the Earth almost 8 times!

In addition, the cost of transportation stems from the resources it requires—labor, equipment, fuel, and infrastructure.

Our participants utilize transportation resources for job and recreational activities. There are various jobs and recreational activities available for individuals with disabilities. Job opportunities may include working with companies such as Complete Vision Care, Jersey Mikes, Nothing Bundt Cakes, and Walgreens.

Recreation options may include adaptive golf, wheelchair bowling, and accessible hiking trails.

Without our donors, none of these activities would be possible.
