Individuals received access to community living through Park Lawn's residential services.

Families and their school aged children received knowledge and guidance through the Building Bridges to the Future program. The program informs families how to secure funding for their child's future when moving from special education to adult services.

196

Individuals received employment opportunities, vocational training and work skills through Park Lawn's Vocational Services.

143

Families were enrolled in Home Based Services, which enables individual's to create a life plan and goals to achieve their desired outcomes. As of June 30, 2017, each Home Based Facilitator had 30—32 people per case load.





Independence

Programs through Park Lawn's Vocational Services provide skills and experience which helps individuals obtain their goal of acquiring a job suited to their interests and abilities.

Choice

If a participant encounters difficulty adjusting to the environment, performing their duties or has a health issue they have the option to transfer to a program that addresses their immediate needs and can return to their job when they are ready.

Access to Community Living

Park Lawn's residential services vary to accommodate the needs of our participants as well as encourage independence. Residents share household responsibilities and participate in the planning of recreational and social activities under the guidance of caring staff.

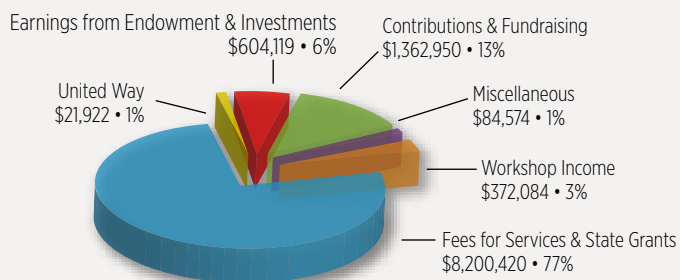

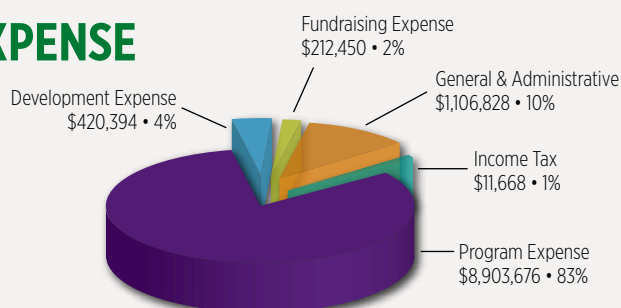

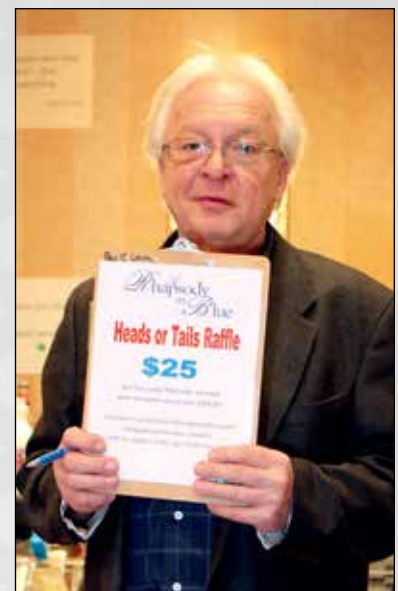
Volunteers
